The Center received 12,440 hours of volunteer services in 2016. At \$22.70 per hour, this amounts to \$274,675 of additional contributions and program service expenses. This hourly rate is the estimated value per hour of volunteer time for Florida as estimated by Independent Sector.

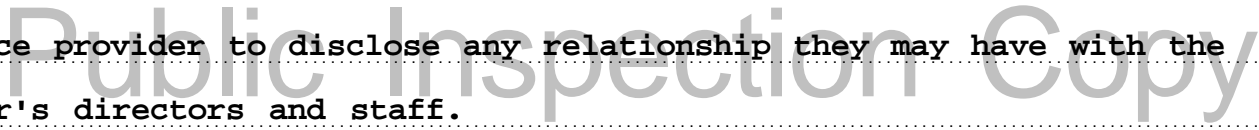
